
Old way





How are payments made?

User fills in the payment form and select the cryptocurrency to pay

Metamouse confirms the transaction and finds a peer to execute the payment

Metamouse confirms the payment and notifies the userh

Metamouse P2P network

Payments are executed by «Verified Payers»

«Verified Payer» is corporate entity or private individual, who has provided full KYC

Each Payer is approved by metamouse compliance

Each Payer earns part of commission



Guarantees

- Each «Verified Payer» holds collateral with Metamouse to participate in the network
- Each Payer can pay invoices up to his collateral level
- If the invoice is **failed** to be paid in 24h:
 - Payer's rating is downgraded
 - Invoice is passed to another Payer





KYC and AML




checks **source** of crypto
